Specifically, participants will learn the following skills:

- Safety and risk management
- Aerial work positioning
- Physics and dynamics
- Lines, slings and rope tools
- Knots, hitches, prussics and terminology
- Rigging equipment
- Compound rigging techniques and planning

Applicable Standards: This course meets the ANSI/ASSE Z490 Criteria for Accepted Practices in Safety, Health, and Environmental Training as well as ANSI Z133.
